Large entry on both Saturday and Sunday, allowing ample competition against international crews for both the Senior and Novice squads. Sunny skies, temperatures up to 22°C, and a cross-tailwind. Crews were entered as; Championship (Senior) or Academic (Club), with all crews racing a time trial, seeding them into subsequent finals based entirely on their times over 1900m, rather than the category the crew is entered under, this encouraged competitive racing and lead to strong results over the weekend.
